## Swimming with dolphins may be prohibited

Government in Hawaii is proposing a prohibition on the popular tourist activity of swimming with dolphins along the Hawaiian coast. Dolphins have been a magnet for tourists over the past decades. However, federal officials say the increasing tourism is harmful to the dolphins because they should be resting and socializing. The National Marine Fisheries Service of the National Oceanic proposes to prohibit swimming with dolphins or approaching within 50 metres of them. That would put an end to many tour group activities, such as sailing alongside the creatures in a boat and snorkeling with them.

Ann Garrett, from the National Marine Fisheries Service, said she didn't think the prohibition would have a big impact on the tourist business in Hawaii. Tour operators do not agree with Garrett's opinion. Tour company owner Kevin Merrill said: "It would be the end of legitimate dolphin swimming. We couldn't offer the people the quality interaction that they expect." Dolphins are usually most active at night and sleep and relax during the day, which is when the tourists interact with them. Garrett said the interaction interferes with the dolphins' health and fitness.
